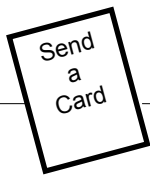

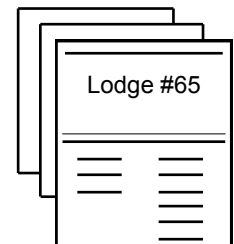

A Resolution

ARTICLE 111, Section 2, of the By-Laws of Lawrence Lodge #65 states:
